Instructions

Applications for Membership in AmCham Hanoi

1. Applicants for Company Membership must provide the AmCham Office staff with a completed Membership Application Package, which includes the following items:
 - Completed AmCham Hanoi Membership Application Form (All items must be completed, including address and contact points of U.S. based corporation or other international firm that established the business in Vietnam).
 - Copy of ID page of Passport (to show citizenship)
 - Copy of Representative Office License (Giay Phep Van Phong Dai Dien), FDI License (Giay Phep Dau Tu), or Branch Office License indicating that the applicant is legally established in Vietnam.
 - Work Permit issued by the Service of Labor, Invalids and Social Affairs, if such permit is required by Vietnamese law.
2. Completed Applications for Membership will be reviewed by the Board of Governors, which determines the acceptability of any applicant to membership, or for renewal or change in classification of membership.
3. Payment of the Annual Membership Fee will be accepted by AmCham Office Staff after the application has been considered and approved by the Board of Governors. In the first year of membership, the Membership Fee may be pro-rated on a monthly basis.

Failure to produce the above documents does not automatically render an applicant ineligible for AmCham membership. However if applicants cannot produce any one of the documents, they should explain the reason.

Under Article III.B.2 of the AmCham Charter the acceptability of any applicant to membership, or for renewal or change in classification of membership in the Chamber shall be determined by the Board of Governors.

The Charter of AmCham provides for the following types of membership:

- **Company Membership:** Substantial investment or operational interest held by United States legal entities or citizens, legally established in Vietnam, as determined by the Board of Governors.
- **Associate Membership:** Any company established under the law of Vietnam that does not qualify for company membership listed above.
- **Additional Membership:** A form of membership available to individuals who are employed by a company holding a Company Membership, other than the Company Member's two Company Representatives.
- **Humanitarian Organizations:** A form of membership available to non-governmental organizations operating legally in Vietnam.
- **Non-Resident Membership:** A form of membership available to any party who would otherwise qualify for Company but for the fact that he, she or it is not resident in Vietnam.
- **Individual Membership:** A form of membership available to any U.S. citizen resident in Vietnam who is engaged in business or a profession in Vietnam, but who cannot qualify for a Company Membership or Additional Membership. The citizenship requirement with respect to an applicant for Individual Membership may be waived by the Board of Governors in its discretion
- **Young Professionals Membership:** A form of membership available to any individual under age 30. We waive the initiation fee. Open to all nationalities.
